## **COMMUNICATIONS AND MULTIMEDIA ACT 1998**

### **MINISTERIAL DIRECTION ON THE STANDARDS ON INTERNATIONAL MOBILE TELECOMMUNICATIONS 2000 TERRESTRIAL COMPONENT**

#### **DIRECTION No. 5 of 2001**

In exercise of the powers conferred by sections 7 and 104 (3) of the Communications and Multimedia Act 1998 (the Act), the Minister hereby directs the Malaysian Communications and Multimedia Commission (the Commission) as follows :

#### **Citation and duration**

1. This direction may be cited as the Ministerial Direction No. 5 of 2001 and shall come into operation on the date of registration of this Direction.

#### **Interpretation**

2. In this Direction, unless the context otherwise requires –

“3GPP” means the Third Generation Partnership Project which comprises regional standards development organizations such as the Japanese Association of Radio Businesses, China Wireless Telecommunications Standards Group, European Telecommunications Standards Institute, the United States Standards Committee T1, Telecommunications Technology Association of Korea and Telecommunication Technology Committee of Japan which agreed to cooperate to produce a complete set of globally applicable Technical Specifications for the Third Generation Mobile System based on the evolved Global System for Mobile Communication core networks and the Universal Terrestrial Radio Access in both Frequency Division Duplex and Time Division Duplex modes.

3. Any terms used in this Direction shall, unless the context otherwise requires, have the same meaning as in the Act or the Regulations made thereunder.

#### **International Mobile Telecommunications 2000**

4. The Commission shall determine a mandatory standard for International Mobile Telecommunications 2000 (“IMT 2000”) terrestrial components.
5. The mandatory standard for IMT 2000 as referred to in paragraph 4 above -




- (a) shall be based on IMT 2000 Code Division Multiple Access Direct Spread and IMT 2000 Code Division Multiple Access Time Division Duplex; and
- (b) the specifications for the above mandatory standards shall have reference to the 3GPP documents from 1 series, 3 series, 4 series, 5 series, 8 series and 21 series until 35 series.

6. The matters referred to in paragraph 5 above are not the only matters which mandatory standard for IMT 2000 may address.
