**COMMUNICATIONS AND MULTIMEDIA ACT 1998**  
**MINISTERIAL DETERMINATION ON FIXED PRICE FOR**  
**THE 900MHz SPECTRUM BAND**  
**DETERMINATION NO. 9 OF 2016**

IN exercise of the powers conferred by section 10 of the Communications and Multimedia Act 1998 [Act 588] ("Act"), the Minister makes the following determination:

**Citation and Commencement**

1. This determination may be cited as the **Ministerial Determination on Fixed Price for the 900MHz Spectrum Band, Determination No. 9 of 2016**.
2. This Determination shall come into operation on the date of its registration.

**Interpretation**

3. Any terms used in this Determination shall, unless the context otherwise requires, have the same meaning as in the Act or the relevant subsidiary legislations made under it.

**Fixed Price**


4. The **Ministerial Determination on 900MHz Spectrum Reallocation, Determination No. 2 of 2016** has determined the following frequency bands be reallocated for spectrum assignments:
  - (a) 885MHz to 915MHz; and
  - (b) 930MHz to 960MHz.
5. The fixed price determined for the spectrum assignments of the reallocated frequency bands in paragraph 4 above shall be as follows:

<b>PAYMENT METHOD</b>	<b>PRICE PER 2x5MHz SPECTRUM BLOCK</b>
One Lump Sum Payment	Ringgit Malaysia Two Hundred Eighteen Million Two Hundred and Five Thousand only (RM218,205,000.00)
Five Equal Annual Payments	Ringgit Malaysia Two Hundred Sixty Three Million Eight Hundred and Twenty Thousand only (RM263,820,000.00)

PAYMENT METHOD	PRICE PER 2x5MHz SPECTRUM BLOCK
Ten Equal Annual Payments	Ringgit Malaysia Three Hundred Thirty Two Million Four Hundred and Thirty Thousand only (RM332,430,000.00)
Fifteen Equal Annual Payments	Ringgit Malaysia Four Hundred Twenty Two Million Two Hundred and Eighty Thousand only (RM422,280,000.00)

6. The fixed price for the spectrum assignments referred to in paragraph 5 above shall be applicable throughout the validity period of the said spectrum assignments.
